**IMPORTANT—PLEASE READ CAREFULLY AND COMPLETELY BEFORE SIGNING**

In consideration of receipt of and foster care of the animal(s) described above and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Sugar Mutts Rescue and the undersigned Foster Caretaker (collectively, "the Parties") agree to be bound by the following terms and conditions of this Agreement:

1. At his or her own expense, the Foster Caretaker shall provide time, proper and sufficient food and water, shelter, kind treatment, and all other proper care of and for the animal(s) at all times. The Foster Caretaker shall never leave the animal(s) unsupervised outside, and shall comply with all city, state and federal laws relating to animal(s). The Foster Caretaker shall provide the above-described services without monetary compensation from Sugar Mutts Rescue.
2. The Foster Caretaker shall timely return the animal(s) to Sugar Mutts Rescue at any time requested orally or in writing by Sugar Mutts Rescue. Unless otherwise specified, this Agreement shall terminate upon receipt of the animal(s) by Sugar Mutts Rescue.
3. The Parties understand and agree that Sugar Mutts Rescue retains full title to and ownership of the animal(s). The Foster Caretaker shall never place the animal in other homes or with other individuals. Nothing contained herein shall be construed to transfer title or ownership, in whole or in part, to the Foster Caretaker or any party other than Sugar Mutts Rescue.
4. Foster Caretaker is fully aware that Sugar Mutts Rescue makes no guarantees or warranties whatsoever regarding the health, temperament, mental disposition and training of the animal(s).
5. Foster Caretaker shall indemnify, defend, and hold harmless Sugar Mutts Rescue, its agents, representatives, employees, and/or their successors and/or assigns from and against any amounts paid to third parties (including reasonable attorneys' fees, regardless of the outcome) as a result of third-party lawsuits, claims, or actions by reason of personal injury (including death) to any person or damage to property arising out of or in connection with this Agreement and/or Foster Caretaker's care, custody, and control (or lack of care, custody, and control) of the animal(s). This paragraph shall survive termination of this Agreement.
6. Sugar Mutts Rescue may at any time inspect the premises in which the animal(s) will be or are maintained for the purpose of determining the suitability of those premises for the care and maintenance of the animal(s).
7. This Agreement contains the full and complete understanding between the Parties and supersedes any and all prior Agreements and understandings pertaining to the terms and conditions herein. This Agreement cannot be modified or amended except by a writing signed by both Parties. This Agreement and any claim or dispute arising out of or related to this Agreement shall be governed by and construed in accordance with the laws in effect in the State of New York, without giving effect to its conflicts of law principles (other than Section 5-1401 of the New York General Obligations Law).
